RESOLUTION ADOPTING EMERGENCY OPERATIONS PLAN FEBRUARY 2022 FOR UPPER NAZARETH TOWNSHIP

WHEREAS, to satisfy the requirements of the Pennsylvania Emergency Management Services Code, 35 Pa. C.S. 7101, et seq., as amended, requiring a disaster emergency plan for municipalities within the Commonwealth of Pennsylvania prescribing those activities to be taken by the municipal government and other community officials to protect the lives and property of the citizens in the event of a natural or human-caused, including terrorism, emergency or disaster; and

WHEREAS, the attached plan as formulated provides a Basic Plan, describing principles and doctrine, a Notification and Resource Manual, which provides listings and means of contacting local and needed resources, and a series of functional checklists which provide details for the accomplishments of the specifics of the operation; and

WHEREAS, it is the intent of Upper Nazareth Township that the Emergency Operations Plan February 2022 shall include all activities in the entire emergency management cycle, including prevention, preparedness, and response and recovery phases, applicable to all response organizations acting for or on behalf of the government or citizens of Upper Nazareth Township.

NOW, DULY RESOLVED by the Board of Supervisors of Upper Nazareth Township, the attached Emergency Operations Plan February 2022 is hereby adopted and established for Upper Nazareth Township, Northampton County, Pennsylvania.
