By completing and submitting the following reservation for booth space, Vendor/Organization/Participant agrees to abide by the terms of this agreement and by the rules and regulations established by Upper Nazareth Township and the Upper Nazareth Township Community Days Committee which is included with this form. Failure to comply with the rules and regulations of Upper Nazareth Township Community Days may result in immediate dismissal from the event without refund and possible exclusion from all future events.

Participation Fee: \$50 for 10'x10' space. Payment for requested 10' x 10' spaces must accompany this application. All Vendors, Organizations, Participants are responsible for providing tents, lights, tables, chairs, and any other items that vendors, organizations, and participants consider necessary to operate and can be contained within assigned space or area.

LIABILITY INSURANCE CERTIFICATE: All Food, Drink, and Amusement Vendors are required to present at time of application a Liability Insurance Certificate. If necessary, Upper Nazareth Township and the Upper Nazareth Township Community Days Committee may request proof of insurance from any vendor, organization, or participant before an application will be approved.

The Liability Insurance Certificate must be in the minimum amount of \$1,000,000 per occurrence, with the following listed as an Additional Insured:

PROFESSIONAL FOOD/DRINK/AMUSEMENT VENDORS: All professional food, drink, and amusement vendors must provide space and area requirements for proper payment calculation. Upper Nazareth Township Community Days Committee reserves the right to approve your application subject to menu and price restrictions and/or changes so as not to duplicate items being sold and/or to create a fair and competitive environment. Food and drink items must be reapproved each year. Food and drink items are not guaranteed year to year.

We are pleased that you will be joining us for this year's Upper Nazareth Township Community Days! You are here as our guest and we look forward to a wonderful event. In order to ensure the safe, smooth and efficient operation of **Upper Nazareth Township Community Days**, it is required that the individuals, vendors, and organizations participating in the event follow these rules and regulations without exception:

1. Upper Nazareth Township Community Days, in its sole discretion, reserves the right to refuse any application.
2. Vendors are accepted on a first come first served basis. Community Days reserves the right to limit vendors with similar products.
3. Upper Nazareth Community Days does not allow vendors of a political or political action nature.
4. Upper Nazareth Township Community Days Committee will assign booth location(s).
5. The Upper Nazareth Township Community Days Committee will be providing times for check-in/setup. Check in/setup will be scheduled for Friday, August 27th.
6. The event hours of operation are as follows:
 - Thursday, September 22nd: 5:00 pm to 10:00 pm
 - Friday, September 23rd: 5:00 pm to 11:00 pm
 - Saturday, September 24th: 3:00 p.m. to 11:00 p.m.
6. Booths MUST be manned at all during event hours.
7. Vendors, Organizations, Participants are responsible for providing tents, lights, tables, chairs, and any other items vendors and organizations consider necessary to operate and can be contained within assigned space or area.
8. Vehicles are not permitted in the festival area during festival hours.
9. All food, drink, and amusement vendors are required to present at time of application a Liability Insurance Certificate in the minimum amount of \$1,000,000 per occurrence. You will not be permitted to participate in the festival if not properly insured. If necessary, Upper Nazareth Township and the Upper Nazareth Township Community Days Committee may request proof of insurance from any vendor, organization, or participant before an application will be approved.
10. Food Vendors - grease disposal will be the responsibility of the vendor.
11. Food and Drink Vendors - food and drink items need to be approved each year; previous year approval does not guarantee you will be permitted to sell the same food and drink items this year.
12. Vendors and organizations are responsible for cleaning up their area at the completion of the event.
13. Any and all dissemination of information, pamphlets, and documentation shall be limited to your
14. assigned booth space and not in the common areas and/or any area outside of your assigned space unless authorized by the Upper Nazareth Township Community Days Committee.
15. Inappropriate behavior will not be tolerated. Inappropriate behavior includes, but is not limited to, smoking in non-designated areas, foul language, and harassing other individuals. If any member of your organization is found to be acting inappropriately, it may result in removal of the individual from the event and closure of your booth without refund.
16. All existing Tuskes Community Park rules are in full force and in effect during festival hours unless authorized by the Upper Nazareth Township Community Days Committee.
17. Upper Nazareth Township or the Upper Nazareth Township Community Days Committee are not responsible for lost, stolen or damaged equipment or material during the event or left overnight.
18. Failure to follow above rules could result in a forfeiture of your deposit.
